## NOTICE OF SPECIAL PUBLIC MEETING

## The meeting will be held on Wednesday, January 31, 2024, at 5:30 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 2. Review and approve the minutes of December 19, 2023, Board of Directors meeting;
- 3. Harris County Constable's Office Security Report, including security issues within the District;
- 4. Bookkeeper's report, including financial investment reports, and authorizing the payment of invoices presented;
