NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Tuesday, August 18, 2026, at 5:30 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Review and approve the minutes of the July 21, 2026, Board of Directors meeting;
3. Harris County Constable's Office Security Report;
4. Approval of Interlocal Agreement for Law Enforcement Services between the District and Harris County, Texas;
5. Bookkeeper's Report, including financial investment reports and authorizing the payment of invoices presented;
6. Approval of Amendment to Engagement Letter for Yield Restriction and Rebate Calculation Analysis between the District and Municipal Risk Management Group, L.L.C.;
7. Tax Assessor-Collector's Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
8. Receive the Financial Advisor's recommendation concerning the District's proposed 2026 tax rate, determine intended tax rate, and authorize:
 - (a) the required notice that the Board will consider adoption of a tax rate; and
 - (b) the means of providing such notice;
9. Report and legal action taken by the District's delinquent tax collections attorney, authorize foreclosure proceedings, installment agreements, the filing of proofs of claim and approval of service terminations;
10. Operation and Maintenance Report, including:
 - (a) Authorizing the repair and maintenance of District facilities;

- (b) Any appeals of District charges; and
 - (c) Approve write-off of uncollectible accounts, including report concerning year to date total for uncollectable accounts;
- 11. Engineering Report, including:
 - (a) Authorizing the design, advertisement for or solicitation of bids and/or award of construction contracts or concurrence in the award of a contract for the construction and/or repair of water, sanitary sewer and drainage facilities within the District; status of construction contracts, including the approval of any change orders or pay estimates, including:
 - (i) Wastewater Treatment Plant Rehabilitation;
 - (ii) Water Plant Nos. 1, 2, 3 and 4 Improvements – D&M Tank, LLC;
 - (iii) Utility Facilities for Kuykendahl Industrial development – ClearX, LLC; and
 - (iv) Clearing and Grubbing at Wastewater Treatment Plant site (DC Contracting Services, LLC);
 - (b) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - (c) Discussion regarding E. Coli monitoring;
 - (d) Discussion regarding tests being conducted to determine the arsenic and iron levels in the District's water supply; and
 - (e) Status of Annual Water Plant Inspections;
- 12. Issuance of utility commitments;
- 13. Storm Water Quality Inspection Report, including proposal(s) for repair;
- 14. Communications Report, including discussion regarding website and messaging services, and take any action necessary and appropriate in connection therewith;
- 15. Status of compliance with annual cybersecurity training as required by Chapters 2054 and 2063, Texas Government Code;
- 16. Authorize filing of Local Government Bond, Tax, and Project Database report with Texas Comptroller of Public Accounts pursuant to Section 403.702, Texas Government Code;
- 17. Attorney's Report;
- 18. Convene executive session pursuant to Open Meetings Act, Texas Government Code Section 551.071 (consultation with attorney), and/or Section 551.072 (acquisition of real property or interests therein);
- 19. Reconvene in open session; authorize the taking of any action resulting from deliberations in executive session; and

20. Matters for possible placement of future agendas.
